Paul opened with prayer at 7 PM followed by informal dialogue. The January 18 Vestry Meeting minutes were reviewed and discussed without subsequent editing.

Motion to accept minutes was made by Michele Alexander and seconded by Mary Baker. No further discussion. Passed unanimously.

- I. Rector's Report
 - A. COVID 19 Paul does not believe the church will be open for Holy Week and Easter. We are following the State of Ohio Health Department guidelines. There are 7 indicators that used to designate a county Red, Yellow, or Orange. Lucas county is still Red. When able, we will be back to requiring reservations. In the Fall there was an average of 30 attendees: 15 @ 8am and 20 @10am. There will also be no Maumee Way of the Cross on Good Friday. The local clergy are planning to put together a joint Good Friday service just as they did for Thanksgiving.
 - B. The new vestry members were introduced: Michele Alexander, Marty Baker, Glenous Favata, and Jonathan Ashton (returning member). Paul reviewed vestry procedures for the benefit of the new members.
 - C. Jaimie Deye and Glenous Favata were nominated as West Mission Area delegates.

Motion to accept the delegates was made by Michele Alexander and seconded by Marty Baker. No further discussion. Passed unanimously.

- D. The West Mission Area has contracted with Jennifer Vasquez to provide programming from now through Pentecost as a private vendor, unaffiliated with any parish. St. Paul's has pledged \$2000 to the West Mission Area as support for this effort.
- E. While the parish secretary, Morgan Browning, is on maternity leave, Paul and Jaimie have been handling the bulletins and website. This will result in a \$4000 savings for the year, enabling the \$2000 pledge towards Jennifer's contract.
