I. Rector's Report

A. COVID 19

Vestry spent some time discussing the 2022 budget in anticipation of approving the final budget in January. The cash position is good, with a projected surplus at the end of the year. Pledges are coming in slowly; we will have a better view of 2022 projected income in January. Vestry needs to make a decision about the Development Fund that has been used to fund the Rector's pension in the 1950's but will be depleted soon. The Finance committee recommended transferring half of the remaining fund for this year's expenses and leave the remaining to be depleted next year.

Motion to transfer \$15,000 from the Development Fund, as recommended by the Finance Committee, to fund the Clergy pension payment was made by Michele Alexander and Marty Baker seconded. No further discussion. Passed unanimously.

Vestry resumed discussion of the Preschool 2022 budget that was postponed from last month. Cristy Seeley had joined the end of the November Vestry meeting and Vestry members had to chance to have their questions answered.

Motion to accept the Elizabeth Wayne Preschool budget as presented in the 2022 preferred column (with raises) was made by Jaimie Deye and Michele Alexander seconded. No further discussion. Passed unanimously.
